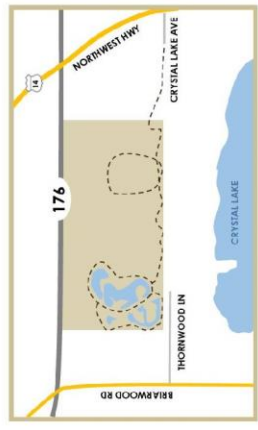


1. Enter the Dog Park at Your Own Risk. You are entering an off-leash dog park.
2. Dog owners or guardians are legally responsible for any damage, injury or illness your dog(s) may cause to itself, other dogs, other people or yourself. The Crystal Lake Park District, their officers, employees, agents and volunteers will be not be responsible in any way for people or their pets while in the dog park.
3. All dogs entering the Hound Town Dog Park must be registered with the Crystal Lake Park District.
4. Dogs must be licensed, vaccinated and healthy.
5. Puppies under six months of age are not allowed inside of the dog park.
6. There is a limit of two dogs per person/handler at one time.
7. Dogs must have a handler over the age of 18 present at all times.
8. All children must be accompanied by an adult. Children should not run with the dogs or chase them in the dog park. Parents should refrain from bringing toddlers or small children into the park. Please remember this is a dog park and not a playground for children.
9. Dogs must wear a collar with identification at all times.
10. Dogs in heat are not allowed inside the dog park.
11. Un-neutered males over the age of six (6) months are not allowed inside of the dog park.
12. Wolves or wolf hybrids are not allowed inside of the dog park.
13. Owners or guardians must carry a leash at all times. Leash and unleash your dog inside the double-gated holding area. Never carry your dog into the dog park.
14. Owners or guardians must not leave their dog(s) unattended or allowed out of sight. You must have visual contact and voice control of your dog at all times.
15. Dog waste must be cleaned up by their owners immediately.
16. Food can be a source of confrontation between dogs. No food items allowed in park if other dogs are present.
17. Do not bring glass containers into the dog park.
18. Water is provided. Watering receptacles should be provided by owners/guardians.
19. Smoking is not allowed on Park District property.
20. Alcohol is prohibited inside or outside of the dog park.

#### **Aggressive Dog Behavior**

- **It is imperative that a description and name of the dog & owner be given at the time of report.**
- **Call the Crystal Lake Park District Administrative Office at 815.459.0680 during regular office hours, or the Non-Emergency Police 815.356.1114, to dispatch a Crystal Lake Park District Police Officer to the Dog Park.**
- **Dog bites that injure another dog or person need to be reported to the Crystal Lake Park Police at 815.356.2415, for a record detailing the event.**
- **If your dog is showing aggressive behavior, leash your dog and remove it from the dog area.**
- **If complaints are registered for aggressive behavior of your dog or non-adherence to rules, your gate key may be revoked. You will be notified by Park District Management or a Park Police Officer if your key fob is revoked. There is no refund. All incidents are reviewed on a case-by-case basis.**
